

## Sustaining Pastoral Excellence – Constancy Funding Application for Self-Selected Renewal Retreat

Pastors and missionaries who feel the need to spend 3 to 7 days in retreat, prayer, and study can make application to the Sustaining Pastoral Excellence program for a grant for such purpose. **An outline of the retreat components will need to accompany the funding application.** Grants of up to \$500 are awarded for personal renewal retreats, and \$4000 for group retreats (4 or more SPE-eligible individuals). All applications must be completed and postmarked by one of the following pre-designated deadlines: February 15, April 1, June 1, August 1, October 1, December 1. These are the dates that application reviews will begin. It is expected that all applications will be turned in by one of the grant deadlines which is at least 8 weeks in advance of the chosen renewal opportunity for which the grant will be used. For example, if the self-selected event is happening on June 7, the application would need to be submitted by the pre-designated date of April 1st. A response will be given to all applicants within a 21 day period after the pre-designated deadline.
